The Belle Glade City Commission will consider adoption of proposed municipal Ordinance, title of which is as follows:

ORDINANCE NO. 2021-06

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF BELLE GLADE, FLORIDA, AMENDING CHAPTER 2 ADMINISTRATION, ARTICLE V BOARDS AND COMMISSIONS, DIVISION 3 CODE ENFORCEMENT; SPECIAL MAGISTRATE TO REMOVE REFERENCES TO THE CODE ENFORCEMENT BOARD; AND AMENDING SECTION 2-264 FINES; LIENS; REDUCTIONS TO AUTHORIZE THE CITY MANAGER TO EXECUTE RELEASES OF LIENS IN CERTAIN SITUATIONS AND TO ADDRESS THE PARTIAL RELEASE OF LIENS AND FOR OTHER PURPOSES; PROVIDING FOR SEVERABILITY, CONFLICTS, CODIFICATION, AND AN EFFECTIVE DATE.

Said Ordinance will be considered for second and final reading during the Regular meeting of the City Commission to be held on the 18th day of October, 2021 at 6:30 p.m., or continuing from time to time and place to place as said meeting may be adjourned to hear the public, at City Hall, 110 Dr. Martin Luther King Jr., Blvd., West, Belle Glade, Palm Beach County, Florida. Copy of said proposed ordinance is available for inspection in the office of the City Clerk located at the aforementioned address.

Should any interested party seek to appeal any decision made by the City Commission with respect to any matter considered at such meetings or hearings, such person will need to insure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
